// ORDER//

Consequent upon re-appointment of 21 officers from State Police Service to the Indian Police Service of Haryana cadre, on the basis of inclusion of their names for review Select List 2012 to 2019 vide MHA's Notification No. I-14013/13/2018-IPS I(E)(II) dated 18.05.2026 and on receipt of the proposal from Government of Haryana, vide their letter No. 4/3/2015-2HG1 dated 20.05.2026, the seniority/year of allotment of the officer is computed under Rule 3 (3) (ii) of the IPS (Regulation of Seniority), Rules 1988, as amended from time to time and other relevant rules. No. 4** shall be placed below Ms **Sangeeta Rani (IPS: 2010)**, the junior most direct recruit IPS officer of 2010 batch of the Haryana Cadre and above Ms **Manisha Choudhary (IPS: 2011)**, the senior most direct recruit IPS officer of 2011 batch of Haryana Cadre.
- (iv) Officers mentioned from **Sl. No. 5 to 8** shall be placed below Shri **Rajendar Kumar Meena (IPS: 2011)**, the junior most direct recruit IPS officer of 2011 batch of the Haryana Cadre and above Shri **Jashandeep Singh Randhawa (IPS: 2012)**, the senior most direct recruit IPS officer of 2012 batch of Haryana Cadre.
- (v) Officer mentioned from **Sl. No. 9** shall be placed below Shri **Sumer Pratap Singh (IPS: 2012)**, the junior most direct recruit IPS officer of 2012 batch of the Haryana Cadre and above Shri **Waseem Akram (IPS: 2013)**, the senior most direct recruit IPS officer of 2013 batch of Haryana Cadre.

- (vi) Officers mentioned from **Sl. No. 10 to 11** shall be placed below Shri **Himanshu Garg (IPS: 2013)**, the junior most direct recruit IPS officer of 2013 batch of the Haryana Cadre and above Shri **Anshu Singla (IPS: 2014)**, the senior most direct recruit IPS officer of 2014 batch of Haryana Cadre.
- (vii) Officers mentioned from **Sl. No. 12 to 19** shall be placed below Shri **Lokender Singh (IPS: 2014)**, the junior most direct recruit IPS officer of 2014 batch of the Haryana Cadre and above Shri **Mohit Handa (IPS: 2015)**, the senior most direct recruit IPS officer of 2015 batch of Haryana Cadre.
- (viii) Officer mentioned from **Sl. No. 20** shall be placed below Shri **Narender Bijarniya (IPS: 2015)**, the junior most direct recruit IPS officer of 2015 batch of the Haryana Cadre and above Shri **Uday Singh Meena (IPS: 2016)**, the senior most direct recruit IPS officer of 2016 batch of Haryana Cadre.
- (ix) Officer mentioned from **Sl. No. 21** shall be placed below Shri **Maqsood Ahmed (IPS: 2016)**, the junior most direct recruit IPS officer of 2016 batch of the Haryana Cadre and above Shri **Varun Singla (IPS: 2017)**, the senior most direct recruit IPS officer of 2017 batch of Haryana Cadre.
