The Government of Haryana vide letter No. 04/03/2015-2HG- 1 dated 11.06.2018 has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota on the basis of inclusion of their names in the Select List of the year 2011 for fixation of seniority/year of allotment. These officers have been appointed to IPS vide GOI Notification No. I-14011/22/2012-IPS.I (II) dated 07.06.2013 and re-notified vide notification dated 23/11/2015.

2. The Seniority/year of allotment of officers of the Select List- 2011 have been computed as per Rule 3 (3) (ii) of the IPS (Regulation of Seniority), Rules 1988, and other relevant rules. Weightage formula as per pre-amended seniority rules are as under:-


