// ORDER//

Government of Karnataka vide their letter number DPAR94 SPS 2023 dated 19.07.2023, has sent a proposal for fixation of seniority/year of allotment of 9 IPS officers, appointed on promotion from SPS quota, on the basis of inclusion of their names in the Select Lists of the year 2017 & 2021 of Karnataka Cadre.

2. The Seniority/Year of allotment of the said officers is computed as per Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 and as per amended seniority rules issued by DOP&T vide their notification dated 18.04.2012. Weightage formula as per amended seniority rules are as under:-
