
// ORDER//

Government of **Kerala**, vide letter no. AIS-C3/70/2022/GAD dated 10.08.2023, has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota of **Kerala Cadre** on the basis of inclusion of their names in the Select List of the year 2017, 2018, 2019 & 2020.

2. The seniority/year of allotment of the officers of Select List of the year 2017, 2018, 2019 & 2020 is computed under Rule 3 (3) (ii) of the IPS (Regulation of Seniority), Rules 1988, amended as per DOP&T vide notification No. 14014/4/2011-AIS-I(B) dated 18.04.2012 and other relevant rules.
