
Government of Maharashtra, vide letter No. IPS-0916/C.R.357/POL-1 dated 24.01.2017, has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota on the basis of inclusion of their names in the Select Lists of the year 2010. 2012, 2013 & 2014 for fixation of seniority/year of allotment. These officers have been appointed to IPS vide GOI Notification No.I-14011/22/2014.IPS. I(II) dated 15.10.2014, I-14011/19/2015.IPS. I(II) dated 05.01.2016, I-14013/57/2014.IPS. I(II) dated 05.04.2019, I-14013/03/2015.IPS. I(II) dated 24.09.2019 and I-14013/35/2014-IPS.I (II) dated 10.05.2019.

2. (a) **Seniority Calculation for Officers from Select List 2010 –**

The Seniority/year of allotment of officers of the Select List - 2010 has been computed as per Rule 3 (3) (ii) of the IPS (Regulation of Seniority), Rules 1988, and other relevant rules. Weightage formulas as per **pre-amended seniority rules** are as under:-


As per Rule 4 of the IPS (Regulation of Seniority) Rules, 1988, the placement of above officers in the Civil List will be as under:-
