// ORDER //

- (iv) Officers mentioned from **Sl. No. 10 to 29** shall be placed below **Shri Amit Tolani (IPS: 2016)**, the IPS officer of 2016 batch of the Madhya Pradesh Cadre and above **Shri Ankit Soni (IPS: 2017)**, the IPS officer of 2017 batch of Madhya Pradesh Cadre.
