// ORDER //

The Government of Madhya Pradesh vide their letter No. F-1-2/2020B-2/do dated 01.07.2022, 24.08.2022 and 05.09.2022 had sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota of Madhya Pradesh Cadre on the basis of inclusion of their names in the Select List of the year 2018 & 2019. These officers have been appointed to IPS vide GOI Notification No. I-14011/03/2019-IPS.I (II) dated 05.02.2020 and Notification No. I-14011/05/2020-IPS.I(II) dated 28.09.2020.

2. The seniority/year of allotment of these officers has been computed under Rule 3(3)(ii) of the IPS (Regulation of Seniority), Rules 1988, as amended vide notification No. 14014/4/2011-AIS-I(B) dated 18.04.2012 and other relevant rules. Modified weightage formula is now as under:-

4. As per Rule 4 of the IPS (Regulation of Seniority) Rules, 1988, the placement of above officers in the Civil List will be as under:-





(ii) Officers mentioned at **Sl. No. 3 to 11** shall be placed below **Shri Shailendra Singh Chauhan (IPS:2012)**, the junior most direct recruit IPS officer of 2012 batch of Madhya Pradesh Cadre and above **Shri Sampat Upadhyay (IPS:2013)**, the senior most direct recruit IPS officer of 2013 batch of Madhya Pradesh Cadre.

5. This order is in supersession of this Ministry's Order No. I-15011/02/2021-IPS-I(E) dated 24.01.2022.
