
**// ORDER//**

Government of Maharashtra vide their letter No.IPS-2022/C.R.342/POL-1 dated 15.06.2023 and letter No.IPS-2023/C.R.245/POL-I, has sent proposals for fixation of seniority/year of allotment of IPS officers, appointed on promotion from SPS quota, on the basis of inclusion of their names in the Select Lists of the year 2019 to 2021 of Maharashtra Cadre. These officers have been appointed IPS vide GOI Notification No I-14011/21/2020-IPS-I(E)(I) dated 14.01.2022 and Notification No. I-14011/09/2022-IPS-I(E)(I) dated 17.10.2023.

2. The Seniority/year of allotment of officers of the Select List 2019 to 2021 has been computed as per Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 and as per amended seniority rules issued by DOP&T vide their notification dated 18.04.2012. 


4. As per Rule 4 of the IPS (Regulation of Seniority) Rules, 1988, the placement of above officers in the Civil List will be as under:-
