ORDER

Whereas, the State Government of Meghalaya vide letter no. HPL 193/89/263 dated 29.01.2019 has requested to revise the year of allotment as 2006 of Sh. Debangshu Sangma & Sh. Heimond Toi as the year of allotment in respect of Sh. D P Marak and Sh. M. Kharamalki has been revised from 2007 to 2006 vide MHA order dated 16.03.2018.

- 2. Whereas, Sh. Debangshu Sangma was appointed in IPS in Select List 2012 in the Meghalaya Segment of Joint Assam-Meghalaya Cadre vide this Ministry's notification dated 27.01.2014 and his year of allotment was fixed as 2007 vide this Ministry's order dated 15.01.2015. Similarly, Sh. Heimond Toi was appointed in IPS in Select List 2014 in the Meghalaya Segment of Joint Assam-Meghalaya Cadre vide this Ministry's notification dated 27.01.2016 and his year of allotment was fixed as 2007 vide this Ministry's order dated 11.03.2016. The year of allotment of Sh. Debangshu Sangma was restricted to 2007, as Sh. D P Marak of Select List 2010 (senior to Sh. Debangshu Sangma) was assigned 2007 as his year of allotment. Similarly, the year of allotment of Sh. Heimond Toi was restricted to 2007, as Sh. Debangshu Sangma of Select List 2012 (senior to Sh. Heimond Toi) was assigned 2007 as his year of allotment.
- 3. Whereas, the year of allotment of officers of Select Lists 2009, 2010 & 2011 of Meghalaya Segment of Joint Assam-Meghalaya Cadre was revised vide this Ministry's order dated 16.03.2018 and the year of allotment of Sh. D P Marak and Sh. M Kharamalki was revised from 2007 to 2006.
- 4. Whereas, consequent upon revision of year of allotment of Sh. D P Marak and Sh. M Kharamalaki from 2007 to 2006, the year of allotment of Sh. Debangshu Sangma and Sh. Heimond Toi is revised as under in modification of this Ministry's order .No. 15011/22/2014-IPS-I dated 15/01/2015 and order No. 15011/6/2016-IPS-I dated 11.03.2016:
