// ORDER//

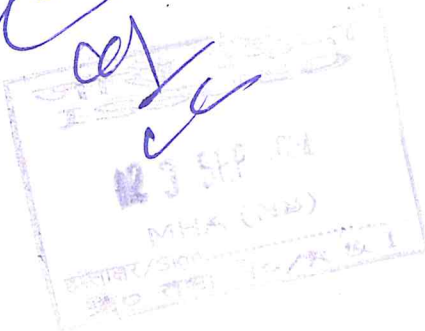
