// ORDER //

The Government of Nagaland vide their letters No. POL/ESTT-1/6/2022/1301 & 1302 dated 21.07.2023, has sent proposals for fixation of seniority of Shri T. Chumrenthung & Shri Yanithung Ezung who were appointed to IPS on promotion from SPS quota, on the basis of inclusion of their names in the Select List of the year 2021 of Nagaland Cadre. Both the officers have been appointed to IPS vide this Ministry's Notification NoI-14011/05/2022-IPS-I(E)(I) dated 07.12.2022.

2. The Seniority/year of allotment of officers of the Select List 2021 has been computed as per Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 and as per amended seniority rules issued by DOP&T vide their notification dated 18.04.2012.
