// ORDER //

The Government of Nagaland vide their letters No. POL/ESTT-1/6/2022/1884 & 1884-I dated 30.05.2024, has sent proposals for fixation of seniority of 04 promotee IPS officers who were appointed to IPS on the basis of inclusion of their names in the Select List of the year 2022 of Nagaland Cadre.

2. The Seniority/year of allotment of officers of the Select List 2022 has been computed as per Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 and as per amended seniority rules issued by DOP&T vide their notification dated 18.04.2012. Weightage formulas as per amended seniority rules are as under:-
