// ORDER //

The Government of Nagaland vide their letter dated 20.10.2022 and 27.10.2022, has sent proposals for fixation of seniority of Smt. Temjensenla Jamir & Shri M James Humtsoe who were appointed to IPS on promotion from SPS quota, on the basis of inclusion of their names in the Select List of the year 2020 of Nagaland Cadre. Both the officers have been appointed to IPS vide this Ministry's Notification NoI-14011/08/2021-IPS-I(E)(I) dated 31.01.2022.

2. The Seniority/year of allotment of officers of the Select List 2020 has been computed as per Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 and as per amended seniority rules issued by DOP&T vide their notification dated 18.04.2012. 
