// ORDER//

Government of Tamil Nadu, vide letter number 40752/Pol.1A/2018-9 dated 02-03-2020, has sent a proposal for seniority fixation of IPS officers appointed on promotion from SPS quota of **Tamil Nadu Cadre** on the basis of inclusion of their names in the Select Lists of the year 2012 to 2017.

2. The seniority/year of allotment of the officers of the Select Lists of the year 2012 to 2017 has been computed under Rule 3 (3) (ii) of the IPS (Regulation of Seniority), Rules 1988, amended as per DOP&T vide notification No. 14014/4/2011-AIS-I(B) dated 18.04.2012 and other relevant rules. 

No. 14 to 22 shall be placed enblock below **Shri G Shashank Sai (RR: 2012)**, the junior most direct recruit IPS officer of 2012 batch of the Tamil Nadu Cadre of IPS and above **Shri Sakhti Ganesan S (RR: 2013)**, the senior most direct recruit IPS officer of 2013 batch of Tamil Nadu Cadre.

No. 23 & 24 shall be placed enblock below **Shri Suguna Singh G (RR: 2013)**, the junior most direct recruit IPS officer of 2013 batch of the Tamil Nadu Cadre of IPS and above **Shri E Sai Charan Tejaswi (RR: 2014)**, the senior most direct recruit IPS officer of 2014 batch of Tamil Nadu Cadre.


