**// ORDER//**

Government of Punjab, vide letter No.1/12/2020-4Home1/814 dated 21.04.2022, has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota of Punjab Cadre on the basis of inclusion of their names in the Select Lists of 2010, 2011, 2013, 2015, 2016, 2017 and 2018 which were notified on 07.04.2021.

2. The seniority/year of allotment of the eligible officers of the select list of the year 2010 & 2011 has been computed under pre-amended Rule 3(3)(ii) of the IPS (Regulation of Seniority), Rules 1988 and as per DoP&T OMs dated 03.11.2017 and 22.01.2018.

- ii. **Officers mentioned from S. No. 3 to 8** shall be placed below Shri Babu Lal Meena (RR:2004), the only direct recruit IPS officer of 2004 batch to the Punjab Cadre and above Shri Harsh Kumar Bansal (RR:2005), the only direct recruit IPS officer of 2005 batch of Punjab Cadre.
- iii. **Officers mentioned at S. No. 9 & 10** shall be placed below Shri Harsh Kumar Bansal (RR:2005), the only direct recruit IPS officer of 2005 batch of Punjab Cadre and above Ms Dhanpreet Kaur (RR:2006), the only direct recruit IPS officer of 2006 batch of Punjab Cadre.
- iv. **Officers mentioned at S. No. 11 to 13** shall be placed below Shri Bikram Pal Singh Bhati (RR:2008), the junior most direct recruit IPS officer of 2008 batch of Punjab Cadre and above Shri Naveen Singla (RR:2009), the senior most direct recruit IPS officer of 2009 batch of Punjab Cadre.
- v. **Officers mentioned at S. No. 14 to 18** shall be placed below Shri Kuldeep Singh (RR:2009), the junior most direct recruit IPS officer of 2009 batch of Punjab Cadre and above Shri Harjeet Singh (RR:2010), the senior most direct recruit IPS officer of 2010 batch of Punjab Cadre.
- vi. **Officers mentioned at S. No. 19 & 20** shall be placed below Ms Alka Meena (RR:2010), the junior most direct recruit IPS officer of 2010 batch of Punjab Cadre and above Shri Vivek Sheel Soni (RR:2011), the senior most direct recruit IPS officer of 2011 batch of Punjab Cadre.
- vii. **Officers mentioned at S. No. 21 to 23** shall be placed below Shri Deepak Hilori (RR:2011), the junior most direct recruit IPS officer of 2011 batch of Punjab Cadre and above Shri Sandeep Kumar Garg (RR:2012), the senior most direct recruit IPS officer of 2012 batch of Punjab Cadre.
