// ORDER//

Government of Punjab vide their letter No.1/12/2020-4H1/1274 dated 27.06.2023, has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota of Punjab Cadre on the basis of inclusion of their names in the Select Lists of 2014 & 2017 which were notified on 07.04.2021.

2. The Seniority/year of allotment of officers of the Select List 2014 & 2017 has been computed as per Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 and as per amended seniority rules issued by DOP&T vide their notification dated 18.04.2012. Weightage formula as per amended seniority rules are as under:-
