// ORDER //

The Government of Rajasthan's vide their letter No. F-6(2)pers/A-1/2017 dated 30.06.2022 has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota of Rajasthan Cadre on the basis of inclusion of their names in the Select List of the year 2017 and 2018. These officers have been appointed to IPS vide GOI Notification No. I-14011/08/2019-IPS.I (II) dated 22.01.2020.

2. The seniority/year of allotment of these officers has been computed under Rule 3(3)(ii) of the IPS (Regulation of Seniority), Rules 1988, as amended vide notification No. 14014/4/2011-AIS-I(B) dated 18.04.2012 and other relevant rules. Modified weightage formula is now as under:-


