Consequent upon the appointment of 04 officers of Telangana Police Service to the Indian Police Service of the Telangana cadre, on the basis of the inclusion of their names in the Select List 2024, vide MHA's Notification No. I-14011/21/2025-IPS I(E)(II) dated 27.10.2025 and on receipt of the proposal from the Government of Telangana, vide their letter No. GAD-Spl.B/544/2024-IPS-1 dated 28.01.2026, the seniority/year of allotment of the officers is computed under Rule 3 (3) (ii) of the IPS (Regulation of Seniority), Rules 1988, as amended vide notification no 14014/4/2011-AIS(I) B dated 18.04.2012 and other relevant rules.
