UT Division (MHA), vide their OM number 14016/04/2019.UTS.I dated 03.10.2022 had sent a proposal for fixation of seniority/year of allotment in respect of Shri Rajesh Deo, IPS officer from **Joint AGMUT Cadre** appointed on promotion from SPS quota on the basis of inclusion of his name in the Select List of the year 2018 which was notified on 31.12.2019.
