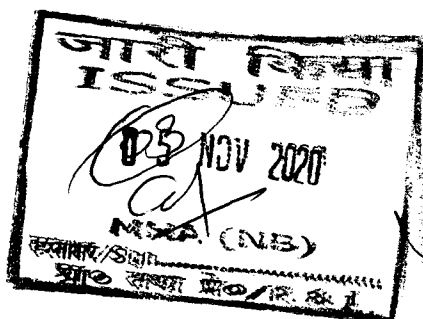
// ORDER //

Government of Madhya Pradesh, vide letter No. F 1-2/2018/B-2/2 dated 14.08.2020, has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota of **Madhya Pradesh Cadre** on the basis of inclusion of their names in the Select List of the year 2017.
