// ORDER//

Government of Telangana, vide letter No. GAD-Spl.B/191/2020-3 dated 04.07.2022 has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota of **Telangana Cadre** on the basis of inclusion of their names in the Select Lists of the year from 2016 to 2020.

2. The seniority/year of allotment of the officers of the Select List of the year 2016 to 2020 has been computed under Rule 3 (3) (ii) of the IPS (Regulation of Seniority), Rules 1988, amended as per DOP&T vide notification No. 14014/4/2011-AIS-I(B) dated 18.04.2012 and other relevant rules. Weightage formula as per amended seniority rules is as under :-



- b) Officers mentioned at Sl. No. 9 shall be placed below Smt. **Ch Sindhu Sharma (RR: 2014)**, junior most direct recruit IPS officer of 2014 batch of the Telangana Cadre and above Smt. **Rakshitha K Murthy (RR: 2015)**, the senior most direct recruit IPS officer of 2015 batch of Telangana Cadre.
- c) Officers mentioned at Sl. No. 10 & 11 shall be placed below Shri **M Rajesh Chandra (RR: 2015)**, junior most direct recruit IPS officer of 2015 batch of the Telangana Cadre and above Shri **Potharaju Sai Chaitanya (RR: 2016)**, the senior most direct recruit IPS officer of 2016 batch of Telangana Cadre.
- d) Officers mentioned from Sl. No. 12 to 15 shall be placed below Shri **Sharat Chandra Pawar (RR: 2016)**, junior most direct recruit IPS officer of 2016 batch of the Telangana Cadre and above Shri **Gaush Alam (RR: 2017)**, the senior most direct recruit IPS officer of 2017 batch of Telangana Cadre.
- e) Officers mentioned from Sl. No. 16 to 20 shall be placed below Smt **Nitika Pant (RR: 2017)**, junior most direct recruit IPS officer of 2017 batch of the Telangana Cadre and above Shri **Yogesh Goutam (RR: 2018)**, the senior most direct recruit IPS officer of 2018 batch of Telangana Cadre.
