**// ORDER //**

Government of Maharashtra vide their letter No.IPS-2022/C.R.342/POL-1 dated 24.01.2023, has sent a proposal for fixation of seniority/year of allotment of IPS officers, appointed on promotion from SPS quota, on the basis of inclusion of their names in the Select Lists of the year 2017 to 2020 of Maharashtra Cadre. These officers have been appointed IPS vide GOI Notification No. I-14011/16/2018.IPS. I(II) dated 08.09.2020 and Notification No I-14011/21/2020-IPS-I(E)(I) dated 14.01.2022.

2. The Seniority/year of allotment of officers of the Select List 2017 to 2020 has been computed as per Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 and as per amended seniority rules issued by DOP&T vide their notification dated 18.04.2012. 4. As per Rule 4 of the IPS (Regulation of Seniority) Rules, 1988, the placement of above officers in the Civil List will be as under:-



- ii. Officers mentioned at SI No. 2 to 3 shall be placed below Shri D A Gedam (RR:2012), the junior most direct recruit IPS officer of 2012 batch of Maharashtra Cadre and above Shri Pandit Chinmay Suresh (RR:2013), the senior most direct recruit IPS officer of 2013 batch of Maharashtra Cadre.
- iii. Officers mentioned at SI No. 4 to 6 shall be placed below Shri Bachchan Singh (RR:2013), the junior most direct recruit IPS officer of 2013 batch of Maharashtra Cadre and above Shri Neelotpal (RR:2014), the senior most direct recruit IPS officer of 2014 batch of Maharashtra Cadre.
- iv. Officers mentioned at SI No. 7 to 15 shall be placed below Shri Mohit Kumar (RR:2014), the junior most direct recruit IPS officer of 2014 batch of Maharashtra Cadre and above Shri Gluge Sandip Bhagwanrao (RR:2015), the senior most direct recruit IPS officer of 2015 batch of Maharashtra Cadre.
- v. Officers mentioned at SI No. 16 to 23 shall be placed below Shri G Vijay Krishna Yadav (RR:2015), the junior most direct recruit IPS officer of 2015 batch of Maharashtra Cadre and above Shri Sameer Aslam Shaikh (RR:2016), the senior most direct recruit IPS officer of 2016 batch of Maharashtra Cadre.
- vi.
