// ORDER //

The State Government of Sikkim vide their letter no. 5077/GEN/DOP dated 06.11.2023 has sent a proposal for fixation of seniority/year of Shri Sharab Tseten Tonyot, IPS officers of Sikkim Cadre appointed by promotion from SPS quota of Sikkim on the basis of inclusion of his name in the Select Lists of the year 2021.
