The State Government of Sikkim vide their letter no. 4199/GEN/DOP dated 05-02-2020 has sent a proposal for fixation of seniority/year of allotment of IPS officers of Sikkim Cadre appointed by promotion from SPS quota of Sikkim on the basis of inclusion of their names in the Select Lists of the year 2015, 2016 and 2017.

2. The seniority/year of allotment of the officers of Select Lists of the year 2015, 2016 & 2017 has been computed under Rule 3 (3) (ii) of the IPS (Regulation of Seniority), Rules 1988, amended as per DOP&T vide notification No. 14014/4/2011-AIS-I(B) dated 18.04.2012 and other relevant Rules. The weightage formula as per amended seniority rules is as under:-

- (ii) Officer mentioned at Sl. No. 2 & 3 shall be placed enblock below **Shri Hari Prasad Chettri (SPS:2009)**, the only IPS officer of 2009 batch of the **Sikkim** Cadre and above **Shri Dr. Siva Prasad Yellasiri (RR:2011)**, the only IPS officer of 2011 batch of **Sikkim** Cadre.
