## // ORDER//

The Government of Bihar vide letter No. No. 01/C01-10-30/1998 dated 06.05.2019, 07-11-2019 and 09-09-2019 has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota on the basis of inclusion of their names in the Select Lists of the year 2014 & 2015 for fixation of seniority/year of allotment. These officers have been appointed to IPS vide GOI Notification No. I.14011/9/2017.IPS. I(II) dated 26<sup>th</sup> May, 2017.

2. The seniority/year of allotment of the officers of the Select Lists of the year 2014 and 2015 has been computed under Rule 3 (3) (ii) of the IPS (Regulation of Seniority), Rules 1988, amended as per DOP&T vide notification No. 14014/4/2011-AIS-I(B) dated 18.04.2012 and other relevant rules.
