// ORDER//

The Government of Gujarat vide their letter No. IPS/102006/GOI-125/B dated 24.01.2017 and 13.07.2018 has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota on the basis of inclusion of their names in the Select Lists of the year 2014, 2015 & 2016 for fixation of seniority/year of allotment. These officers have been appointed to IPS vide GOI Notification No. I.14011/11/2015.IPS. I(II) dated 06th May, 2016 and No. I.14011/16/2017.IPS. I(II) dated 13th April, 2018.

2. The fixation of seniority of the Select Lists of the year 2014 have been computed under Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 as per amended seniority rules of DOP&T issued vide their notification dated 18.04.2012. 
