The State Government of Assam vide letter number HMA. 14/2020/25 dated 14-02-2020 has sent a proposal for fixation of Seniority of IPS Officers appointed on promotion from SPS quota of Assam Segment of Joint Assam-Meghalaya Cadre in the Select Lists 2015 & 2017 for fixation of Seniority / year of allotment.




