// ORDER //

The Government of Tripura, vide letter No. F.2(1)-GA(P&T)/16 dated 02.12.2019, has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota on the basis of inclusion of their names in the Select List of the year 2016.
