// ORDER //

Governments of Tripura vide their letter No. F.2(1)-GA(P&T)/16(Part-1) dated 26.02.2024, has sent a proposal for fixation of seniority/year of allotment of 10 IPS officers, appointed on promotion from SPS quota, on the basis of inclusion of their names in the Select Lists of the year 2017 to 2022 of Tripura Cadre.

2. The Seniority/Year of allotment of the said officers is computed as per Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 and as per amended seniority rules issued by DOP&T vide their notification dated 18.04.2012. Weightage formula as per amended seniority rules are as under:-

c. Officers mentioned at **Sl. No. 5 to 10** shall be placed below Shri **Kiran Kumar K (IPS: 2014)**, the IPS officer of 2014 batch of Tripura Cadre and above Shri **Shashvat Kumar (IPS: 2016)**, the IPS officer of 2016 batch of Tripura Cadre.
