// ORDER //

The Government of Tripura, vide letter number F.2(1)-GA(P&T)/16 dated 14.03.2022, has sent a proposal for fixation of seniority of Shri Kamal Chakraborty (IPS officer appointed on promotion from SPS quota on the basis of inclusion of his name in the Select List of the year 2016.
