// ORDER //

Government of **Uttar Pradesh**, vides letter no. 872/छ:पु से -2-22024 dated 18.10.2024, has sent a proposal for fixation of seniority of 26 promote IPS officers who have been appointed to IPS on promotion quota against the Select List of the 2022 of Uttar Pradesh Cadre.

2.
