Government of **Uttar Pradesh**, vides letter no. 770/छ:पुंसें-2-24 dated 10.06.2024, has sent a proposal for fixation of seniority of 11 promote IPS officers who have been appointed to IPS on promotion quota against the Select List of the 2020 of Uttar Pradesh Cadre.

2.
