// ORDER //

Government of Uttar Pradesh vide letter number 84/छ: पु०से०-2-22-538(3)/2018 dated 19.01.2022 has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota on the basis of inclusion of their names in the Select List of the years 2016 and 2017. These officers have been appointed to IPS vide GOI Notification No. I-14011/02/2017-IPS.I (II) dated 03.05.2017 and GOI Notification No. I-14011/11/2018-IPS.I (II) dated 13.08.2018.

2. The Seniority/year of allotment of officers of the Select List 2016 and 2017 has been computed as per Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 and as per amended seniority rules issued by DOP&T vide their notification dated 18.04.2012. "Officers mentioned at SI No. 5 shall be placed below Shri Surya Kant Tripathi, the promotee IPS officer of 2011 batch of Uttar Pradesh Cadre and above Shri Bikash Kumar Baidya, the promotee IPS officer of 2011 batch of Uttar Pradesh Cadre".

"Officers mentioned at SI No. 6 shall be placed below Shri Bikash Kumar Baidya, the promotee IPS officer of 2011 batch of Uttar Pradesh Cadre and above Shri Rajesh Kumar Saxena, the promotee IPS officer of 2011 batch of Uttar Pradesh Cadre".

"Officers mentioned at SI No. 7 shall be placed below Shri Rajesh Kumar Saxena, the promotee IPS officer of 2011 batch of Uttar Pradesh Cadre and above Shri Om Prakash Singh, the promotee IPS officer of 2011 batch of Uttar Pradesh Cadre".

5. The concerned officers may kindly be informed accordingly.


