UT Division (MHA), vide their letter number 14016/04/2019.UTS.I dated 29.11.2021 had sent a proposal for fixation of seniority/year of allotment of three IPS officers from **Joint AGMUT Cadre** namely, Shri Sanjay Bhatia, Shri Rajendra Singh Sagar and Shri Rakesh Kumar, appointed on promotion from SPS quota on the basis of inclusion of their names in the Select List of the year 2016 and 2017 respectively.
