// ORDER //


The Government of Uttarakhand vide their letter No. HS1-IPS/16/2022 dated 24.07.2023 has sent a proposal for fixation of seniority of IPS officers appointed on promotion from State Police Service of Uttarakhand Cadre on the basis of inclusion of their names in the Select List of the year 2018, 2019 & 2020.

2. The seniority/year of allotment of these officers is computed under Rule 3(3)(ii) of the IPS (Regulation of Seniority), Rules 1988, as amended vide notification No. 14014/4/2011-AIS-I(B) dated 18.04.2012 and other relevant rules. Modified weightage formula is now as under:-
