**// ORDER //**

Government of Andhra Pradesh vide their letter No.1319207/SC.C/A1/2021 dated 29.04.2024, has sent a proposal for fixation of seniority/year of allotment of 09 IPS officers, appointed on promotion from SPS quota, on the basis of inclusion of their names in the Select Lists of the year 2020 & 2021 of Andhra Pradesh Cadre.

2. The Seniority/year of allotment of these IPS officers is computed as per Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 and as per amended seniority rules issued by DOP&T vide their notification dated 18.04.2012. Weightage formulas as per amended seniority rules are as under:-

(ii) Officers mentioned from **Sl. No. 8 to 9** shall be placed below **Shri Tushar Dudi (IPS: 2018)**, the junior most direct recruit IPS officer of 2018 batch of the Andhra Pradesh Cadre and above **Shri K V Maheswarareddy (IPS: 2019)**, the senior most direct recruit IPS officer of 2019 batch of Andhra Pradesh Cadre.
