// ORDER //

The Government of **Andhra Pradesh** vide their letter no. 23/SC.C/A1/2014 dated 04.01.2018 & 219834/SC.C/A1/2014 dated 02.12.2020, has sent a proposal for fixation of seniority/year of allotment of IPS officers appointed on promotion from SPS quota on the basis of inclusion of their names in the Select Lists of the year 2011, 2012 & 2013. These officers have been appointed to IPS vide GOI Notification No. I-14011/04/2017.IPS. I(II) dated 03.08.2017 and I-14011/26/2014.IPS. I(II) dated 16.03.2015.

2. Initially, the officers were appointed to IPS of unified Andhra Pradesh but now these officers have been bifurcated between State Govt.s of Andhra Pradesh & Telangana by DoP&T vide order no. 29/10/2016-SR(S) dated 28.10.2020.
