State Govt. of Chhattisgarh, vide letter no. F-1-08/2019/2-Home/IPS dated 20.06.2024, has sent a proposal for seniority fixation of Shri Dharmendra Singh Chhawai, IPS who was appointed to IPS by way of promotion from SPS quota on the basis of inclusion of his name in Select List of 2019 of Chhattisgarh Cadre.
