// ORDER //

Consequent upon appointment of 14 officers of West Bengal Police Service to the Indian Police Service of West Bengal cadre, on the basis of inclusion of their names for Select List 2021, 2022 & 2023 vide MHA's Notification No. I-14011/25/2024-IPS-I(I) dated 24.12.2025 and on receipt of the proposal from Government of West Bengal, vide their letter No. 534-P.S. Cell/HR/O/3P-03/2025 dated 16.03.2026, the seniority/year of allotment of the officers is computed under Rule 3 (3) (ii) of the IPS (Regulation of Seniority), Rules 1988, as amended from time to time and other relevant rules. (iii) Officers mentioned from Sl. No. 4 to 9 shall be placed below Shri Polumati Sharanya (IPS: 2019), IPS officer of 2019 batch of the West Bengal Cadre and above Shri George Allen John (IPS: 2020), IPS officer of 2020 batch of the West Bengal Cadre.

(iv) Officers mentioned from Sl. No. 10 to 14 shall be placed below Shri Krishna Gopal Meena (IPS: 2020), IPS officer of 2020 batch of the West Bengal Cadre and above Shri Raviraj Awasthi (IPS: 2021), IPS officer of 2021 batch of the West Bengal Cadre.




