Consequent upon appointment of 25 officers of Tamil Nadu Police Service to the Indian Police Service of Tamil Nadu cadre, on the basis of inclusion of their names for Select Lists 2018, 2019, 2020, 2021 & 2022 vide MHA's Notification No. I-14011/27/2023-IPS-I (E) (I) dated 21.01.2025 and on receipt of the proposal from Government of Tamil Nadu, vide their letter No. 9868373/Police-1/2025-2 dated 02.07.2025, the seniority/year of allotment of the officers is computed under Rule 3 (3) (ii) of the IPS (Regulation of Seniority), Rules 1988, as amended from time to time and other relevant rules. 
