Consequent upon appointment of 02 officers of Meghalaya Police Service to the Indian Police Service of Meghalaya Segment of Assam-Meghalaya cadre, on the basis of inclusion of their names for Select List 2024 vide MHA's Notification No. I-14011/03(M)/2025-IPS-I(E)(II) dated 20.05.2025 and on receipt of the proposal from Government of Meghalaya, vide their letter No. HPL.27/2004/135 dated 09.06.2025, the seniority/year of allotment of the officers is computed under Rule 3 (3) (ii) of the IPS (Regulation of Seniority), Rules 1988, as amended from time to time and other relevant rules.
