**// ORDER //**

Government of Himachal Pradesh, vide letter No. Home-D-B(15)-9/2013-I dated 22.02.2023, has sent a proposal for fixation of seniority of Shri Padam Chand who was appointed to Indian Police Service (IPS) in **Himachal Pradesh Cadre** on the basis of inclusion of his name in the Select List of the year 2020.

4. As per Rule 4 of the IPS (Regulation of Seniority) Rules, 1988, the placement of above officer in the Civil List will be as under:-


