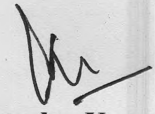

- iii. Officers mentioned from Sl. No. 7 to 10 shall be placed below Shri Manish (IPS: 2020), the junior most direct recruit IPS officer of the 2020 batch of the AGMUT Cadre and above Ms Kartik Shrotriya (IPS: 2021), the senior most direct recruit IPS officer of 2021 batch of AGMUT Cadre.
