Government of Tamil Nadu, vide letter number 4371/Pol.1A/2022 dated 25.04.2022, has sent a proposal for re-fixation of seniority of IPS officers who are re-appointed on promotion from SPS quota of **Tamil Nadu Cadre** on the basis of inclusion of their names in the Review Select Lists of the year 2015 and 2016.

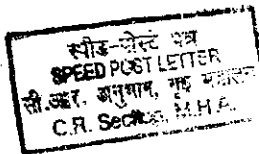
