Consequent upon appointment from State Police Service to the Indian Police Service of Tripura cadre, on the basis of inclusion of their names in the Select List 2024 vide MHA's Notification No. I-14011/22/2025-IPS I(E)(II) dated 19.11.2025 and on receipt of the proposal from Government of Tripura, vide their letter No. F.2(5)-GA(P&T)/2024 dated 16.01.2026, the seniority/year of allotment of these officers is computed under Rule 3 (3) (ii) of the IPS (Regulation of Seniority), Rules 1988, as amended vide notification no 14014/4/2011-AIS(I) B dated 18.04.2012 and other relevant rules.
