// ORDER //

The Government of Uttarakhand vide their letter No.354/XX-1-2020-2(1)2001.T.C. dated 07.07.2020, has sent a proposal for fixation of seniority/year of allotment of IPS officers appointed on promotion from SPS quota on the basis of inclusion of their names in the Select Lists of the year 2016 & 2017. These officers have been appointed to IPS vide GOI Notification No. I-14011/04/2017.IPS. I(II) dated 03.08.2017 and I-14011/05/2018.IPS. I(II) dated 21.06.2018.

2. The Seniority/year of allotment of officers of the Select List 2016 & 2017 has been computed as per Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 and as per amended seniority rules issued by DOP&T vide their notification dated 18.04.2012.
