**Subject: Determination of vacancies for appointment by promotion of officers from Arunachal Police to Indian Police Service of Joint AGMUT Cadre (Arunachal Pradesh Segment) for the Select List -2022 and 2023.**

Sir,

I am directed to refer to UT Division's OM number 14016/01/2024-UTS.I dated 05.02.2024 on the subject and to say that the last Select List was prepared and finalized for the Select List of year 2018 where 02 appointments were made against 02 vacancies. The vacancies in the promotion quota of Indian Police Service of the State of Arunachal Pradesh for the year 2019, 2020 and 2021 was determined as 'Nil'.

2. The authorised promotion quota of Arunachal Pradesh Segment of Joint AGMUT Cadre of IPS as on 01.01.2023 was 20 & UT Division has mentioned that 20 Officers were in position as on due date, therefore there was no vacancy for appointment by promotion of officers from Arunachal Police to Indian Police Service of Joint AGMUT Cadre (Arunachal Pradesh Segment) for the Select List-2022.

3. Further, the authorised promotion quota of Arunachal Pradesh Segment of Joint AGMUT Cadre of IPS as on 01.01.2024 was 20 & UT Division has mentioned that 18 Officers were in position as on due date, which makes a total of 02 vacancies. Out of these 02 vacancies, 01 vacancy has occurred due to demise of Shri Mari Riba, IPS 2004 on 27-08-2023 and retirement of 01 officer (Shri Michi Paku, IPS 2004, Retired on 31-12-2023).

4. Therefore, in terms of the provisions contained in Rule 4 (2) (3) of the IPS Recruitment Rules, 1954 read with IPS (Appointment by Promotion) Regulations, 1955, Nil vacancy for the Select List year 2022 and 02 vacancies are determined for the Select List 2023 for appointment by promotion of officers from Arunachal Pradesh Police Service to Indian Police Service of Joint AGMUT Cadre.
