I am directed to refer to UT Division's OM No. 14016/02/2026-UTS I dated 07.01.2026 on the subject cited above and to say that the last Select List for the Mizoram Segment of AGMUT cadre was prepared and finalized for the year 2024, and 05 appointments were made against 05 vacancies vide Notification No. I-14011/02(M)/2025-IPS.I dated 11.09.2025.

2. Further, the authorized promotion quota of the Mizoram Segment of the AGMUT Cadre of IPS as of 01.01.2026 was 13, whereas 10 officers were in position on the due date, thus making 03 vacancies in total. Out of these 03 vacancies, 01 vacancy has arisen due to the retirement of 01 officer during the year 2025 and 02 vacancies have been arisen consequent upon the cadre review of the IPS of Joint AGMUT Cadre, as notified by the DoP&T on 03.01.2025.

Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954, read with Regulation 5(1) of the IPS (Appointment by Promotion) Regulations, 1955, **03 (Three)** vacancies are determined for the Select List of the year **2025** for appointment by promotion of UT Police Service officers to the UT Segment of AGMUT Cadre of Indian Police Service.

4. The UT Division and the Commission are requested to take further necessary action as required under the IPS (Appointment by Promotion) Regulations, 1955.
