Sub: Re-determination of vacancies for the Select List 2023 and determination of vacancies for the Select List 2024 for appointment by promotion to the Indian Police Service of UT Segment of AGMUT Cadre.

Sir.

I am directed to refer to UT Division's OM No. 14016/04/2024-UTS I dated 04.02.2025 & 14016/01/2025-UTS I dated 03.02.2025 on the subject cited above and to say that this Ministry has already determined 08 vacancies for the Select List 2023 vide letter dated 01.03.2024 due to retirement of 08 IPS officers.

- 2. The last Select List was prepared and finalized for the year 2022, and 06 appointments were made against 07 vacancies vide Notification No. I- 14011/17/2023-IPS.I dated 12.12.2024. The name of Shri Shive Kesari Singh was included in the Select List 2022 provisionally subject to clearance in criminal proceeding pending against him. Shri Shive Kesari Singh was not appointed to the IPS during the validity period of Select List 2022. Since Select List 2022 has expired, the unfilled vacancy of Select List 2022 due to the non-appointment of Shri Shive Kesari Singh is required to be carried forward to the year 2023.
- 3. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954, read with Regulation 5(1) of the IPS (Appointment by Promotion) Regulations, 1955, **09 (01 carried forward + 08 Superannuation)** vacancies are re-determined for the Select List of the year **2023**.
- 4. Further, the authorized promotion quota of the UT Segment of the AGMUT Cadre of IPS as of 01.01.2025 was 59, whereas 48 officers were in position on the due date, thus making 11 vacancies in total. Out of these 11 vacancies, 09 vacancies are being determined for the Select List year 2023 as per paragraph 3 above, and the remaining 02 vacancies have arisen due to the retirement of 02 officers during the year 2024.
- 5. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954, read with Regulation 5(1) of the IPS (Appointment by Promotion) Regulations, 1955, **02** vacancies are determined for the Select List of the year **2024**.
- 6. The UT Division and the Commission are requested to take further necessary action as required under the IPS (Appointment by Promotion) Regulations, 1955.
