**Subject: Determination of vacancies for appointment by promotion of Assam Police Officers to IPS of the Assam segment of the Joint Assam-Meghalaya Cadre for the Select List 2024.**

Sir,

I am directed to refer to the Government of Assam's letter No. HMA.5/2025/42 dated 07.02.2025 and No. HMA.01/2025/47 dated 26.03.2025 on the subject and to say that the last Select List was prepared and finalized for the years 2019, 2020, 2021, 2022, and 2023, wherein out of 23 vacancies, 17 vacancies were filled vide Notifications dated 17.01.2025.

2. The authorized promotion quota of the Assam segment of the Joint Assam-Meghalaya Cadre of IPS as of 01.01.2025 was 42, whereas 15 officers were in position on the due date, thus making 27 vacancies in total. Out of these 27 vacancies, 17 vacancies have already been filled for the Select list 2019, 2020, 2021, 2022, and 2023 vide Notification dated 17.01.2025. Further, 04 vacancies have arisen due to the retirement of 04 promotee IPS officers during the year 2024, and 06 unfilled vacancies of the Select Lists 2019, 2020, 2021, and 2022 to 2023 due to non-appointment into the IPS need to be carried forward to the year 2024.

3. Therefore, in terms of the provisions contained in Rule 4(2) of the IPS Recruitment Rules, 1954, read with Regulation 5(1) of IPS (Appointment by Promotion) Regulations, 1955, **10 (06 carry forward + 04 superannuation)** vacancies are determined for the Select List of the year 2024 for appointment by promotion for the appointment by promotion of Assam Police Service officers to the Assam segment of the Joint Assam-Meghalaya cadre of the Indian Police Service.

4. The State Government and the Commission are requested to take further necessary action as required under the IPS Appointment by Promotion Regulations, 1955.
